

RULES OF THE CAMPING FIELD MYSTIC FESTIVAL 2023

1. These regulations, hereinafter referred to as the "**Regulations**", apply to all persons staying on in the camping, operating **from 06/06/2023 from 16.00 to 11/06/2023 until 12.00** on the area designated by the Organizer, located on the Square Zebrań Ludowych in Gdańsk, located at the Ofiar Katynia roundabout, hereinafter referred to as: "**Camping**". Camping is organized for the Mystic Festival 2023, held on 7-10.06.2023, hereinafter referred to as: "**the Festival**".
2. The regulations are issued by the organizer of the Festival - Mystic Coalition limited liability company Sp. k., entered into the Business Register of the National Court Register under KRS No. 0000754728, NIP 5130257272, REGON 38163305200000, address: Minoga 127 32-046 Kraków, hereinafter referred to as the "**Organizer**".
3. The right to purchase an admission ticket to the camping is granted only on the condition of purchase festival pass.
4. The right to enter the camping is granted to people who have shown an admission ticket to the camping or who have individually received from the Organizer the right to enter the camping, subject to paragraph 6.
5. A juvenile under the age of 16 has the right to enter the camping only under the care of her adult guardian/parent, after showing tickets to the camping both by the juvenile (subject to the juvenile under the age of 13 doesn't is required to have an entrance ticket to the camping), as well as his adult guardian/parent and after presenting a document confirming the age of the juvenile and after submission to the Organizer by legal guardian / parent declaration of responsibility for a juvenile, according the template **attached to the Regulations**.
6. Before entering the camping for the first time, the entrance ticket to the camping will be scanned and replaced by the Organizer with an identifier in the form of a wristband, which each person having the right to enter the camping is obligated to have on hand for a period functioning of the camping, hereinafter referred to as the "**Identifier**". The identifier can be used only one person. It is forbidden to give the identifier to other people. Right of residence on the premises of the camping and every day entry to the camping is allowed only to those who have an undamaged identifier on their hands, issued by The organizer.
The unique barcode on each admission ticket entitles you to exchange the ticket for identifier only on first scan.
7. At the camping, there are security services appointed by the Organizer, who are tasked with take care of the safety of people staying in the camping, hereinafter referred to as "**Security Staff**".
8. Security staff are required to wear in a visible place an ID issued by Organizer, which contains the following information: name of the issuer, identification number and face image, date of validity, stamp and signature of the issuer.

9. People staying at the camping are required to have a valid document with them confirming the identity, which should be understood as: identity card, temporary identity card, passport, driving license, school or student ID, stating document the identity of the foreigner or another document confirming the identity, provided with an image face and age.
10. Security staff during the sale of entry tickets to the camping and at the entrance to the field Campers, may require from a person entering the camping or making a purchase ticket, presentation of a document confirming her identity and age.
11. People on the camping are obliged to behave in a non-threatening manner the safety of other people, and in particular comply with the provisions of the Regulations.
12. Security staff are entitled to:
 - a) checking and confirming the authorization to stay at the camping and in case of finding that there are no such rights - summoning them to leave the camping,
 - b) identification of persons in order to establish their identity,
 - c) viewing the contents of the luggage and clothing of people on the camping, in case of suspicion that these persons are bringing in or possessing items that is prohibited in the camping, in accordance with the Regulations,
 - d) issuing order orders to persons disturbing public order or maintaining not in accordance with the Regulations, and in the event of failure to comply with these instructions - call them to leave the camping,
 - e) capture, in order to immediately hand over to the Police, people who pose a direct threat to goods or persons subject to security and persons committing prohibited acts.
13. Actions taken by Security Staff should be performer in a manner that respects human dignity and other personal rights of the person, against which they were taken.
14. The use of means of direct coercion and documenting this use by the services order or security, is carried out in accordance with the principles set out in the Act of May 24, 2013 on measures of direct coercion and firearms.
15. In the camping and in its close proximity, it's forbidden to:
 - 1) bring, possess and use: weapons or other dangerous items, explosives, pyrotechnics, fire-fighting materials, dangerous, alcoholic beverages with an alcohol content above 4.5%, substances, intoxicants or psychotropic substances, stun guns, gas throwers, knives, sticks, chain, firecrackers, smoke candles, lasers, laser pointers, and other items they could be used as missiles and any similar, any kind sharp-pointed objects, gas cylinders, solid or liquid fuel stoves, drones and unmanned aerial vehicles,
 - 2) conducting any commercial or other activity without the Organiser's consent earning money,
 - 3) smoking tobacco and cigarettes outside designated smoking areas,
 - 4) taking care of physiological needs outside toilets,

- 5) throwing any objects,
- 6) use open fire in and near tents,
- 7) burning campfires,
- 8) use grill devices outside the designated area,
- 9) setting up tents with an area of more than 10 m²,
- 10) connecting to the existing electrical network, outside designated places,
- 11) destruction of greenery,
- 12) devastation of infrastructure and tents located on the campsite,
- 13) disturbing order and littering the area,
- 14) bringing animals, except guide dogs,
- 15) entry and parking of motor vehicles, caravans and others vehicles, without the Organiser's permission,.

16. Security staff are entitled to:

- 1) determining the authorization to stay in the campsite and identification persons to establish their identity;
- 2) summoning people to leave the campsite in the event of a lack the right to stay on its premises or to find that order is disturbed or non-compliance the Regulations;
- 3) catch in the camping of people who are obviously direct threat to human life or health, as well as protected property, in order immediate surrender of these persons to the Police;
- 4) use or harness of direct coercion measures, on the terms specified in the provisions of the Act of August 22, 1997 on the protection of persons and property (Journal of Laws 1997 No. 114 item 740 as amended);
- 5) use or harness of firearms in accordance with the provisions of the Act of August 22, 1997 on the protection of persons and property (Journal of Laws 1997 No. 114, item 740, as amended);
- 6) refusing entry to the camping and staying on it to a person who in particular:
 - a) is under the visible influence of alcohol, intoxicants, psychotropic or other similar agents;
 - b) carrying weapons or other dangerous items, explosives, pyrotechnic products, fire hazardous materials, alcoholic beverages, narcotic drugs or psychotropic substances, or other products, drinks, drugs or substances the possession of which is prohibited in accordance with the Regulations;
 - c) behaves aggressively, provocatively or otherwise creates threat to security or public order;
 - d) doesn't have the right to enter the Camping;

17. All persons staying at the campsite are obliged to comply with Security Staff orders. Refusal to comply with these instructions may only result from their contradiction with generally applicable law.

18. It's forbidden to disturb or interfere with the surface of the Camping beyond the works necessary for the proper installation and maintenance of the tent. The participant undertakes to restoration to its original condition of the area it occupied no later than before the end of the period functioning of the Camping.

20. The Regulations come into force on 01/10/2023.
